# Wheeler Opens New Community Health Center Location in Waterbury

Saint Mary's Hospital, a Regional Health Ministry of Trinity Health of New England, has received approval from the State Office of Health Strategy to transition its outpatient behavioral health clinic to Wheeler Clinic, which is establishing a new Family Health & Wellness Center in Waterbury. The transition is expected to be complete by September 2019.

The Wheeler Family Health & Wellness Center at 100 Jefferson Square in Waterbury will be Wheeler's fourth, with other locations in Bristol, Hartford, and New Britain. As a federally qualified health center, Wheeler is part of a network of community health centers nationwide that serve the health care needs of more than 28 million Americans. In January, Wheeler received approval from the U.S. Health Resources and Services Administration (HRSA) for its application for health center expansion into Waterbury, which allows Wheeler to deliver integrated primary care and behavioral health center services at the site.

"Wheeler has a proven track record of providing Behavioral/Mental Health treatment throughout the state. We are very excited to welcome them into the community in collaboration with Saint Mary's Hospital," said Saint Mary's Hospital President, Steven Schneider, M.D., M.B.A.

"Wheeler is uniquely positioned to address the unmet need for integrated primary care and behavioral health services in Waterbury, particularly among adults with serious mental illness and co-occurring substance use disorders," said Susan Walkama, LCSW, Wheeler's president and chief executive officer. "This population is often reluctant to seek primary care, experiences disparities in access to health care, and generally has poorer health outcomes."

Wheeler has provided a wide array of services in the Brass City since 1986, and currently operates two offices and numerous programs in the city, including foster care, in-home family therapy, and alcohol and substance abuse education programming.



Wheeler will provide all behavioral health services currently available at the Saint Mary's Behavioral Health Clinic, including intensive outpatient (IOP), behavioral health outpatient services (individual, family, and group therapies), and psychiatric services, including psychiatric evaluations and medication management. There are no planned reductions or interruptions in any of the services provided.

As a community health center, Wheeler also will offer an expanded array of services for existing and new patient services for individuals and families in Greater Waterbury and surrounding towns.

Waterbury community health center services will include:

- Primary care;
- Medication-assisted treatment for alcohol or opiate addiction;
- Linkages to specialty and ancillary services like dental care;
- Care management for adults with complex health care needs and behavioral health concerns;
- Laboratory services;
- Prevention, health promotion, and wellness services; and
- Chronic disease management for asthma, diabetes, hypertension/heart health, HIV, and Hepatitis C treatment and services.

Wheeler's integrated primary and behavioral health care service model, embedded in trauma-informed and culturally- and gender-responsive approaches, reduces barriers to care and provides a more effective path to primary and preventative care for individuals with serious mental illnesses and substance use disorders.

# **Promoting Positive Parenting**

# Wheeler is First in Connecticut to Implement HealthySteps

A secure parent-child bond is critical to a child's development because it fosters a sense of security, self-esteem, and resilience and is an essential building block for forming strong relationships in life.

As part of a comprehensive effort to meet the mental health and primary care needs of its youngest patients, Wheeler is the first in Connecticut to implement **HealthySteps**, a program of **ZERO TO THREE**, designed to strengthen parent-child bonds through screening, referral, and treatment.

HealthySteps is a national evidence-based, interdisciplinary pediatric primary care program that promotes positive parenting and healthy development for babies and toddlers, with an emphasis on serving families living in low-income communities.

The program serves children birth through five years old who receive pediatric services at Wheeler's Family Health & Wellness Center at 43 Woodland Street in Hartford. Wheeler's integrated care team, comprising a pediatrician, senior integrated health care psychologist, medical and dental assistants, care and practice managers, early childhood professionals, social workers, and others, were trained in this model in June.

"We are thrilled that Wheeler is the first to implement this program in Connecticut and look forward to meeting the needs of children and families in Greater Hartford," said Rahil D. Briggs, Psy.D., national director of HealthySteps. "There is no time more important for young children's brain development than the first few years of life, when they also happen to visit their pediatrician and pediatric care team often—12 to 13 times in the first few years of life. We will work closely with the Family Health & Wellness Center team to leverage the value of those frequent

visits and further encourage secure parent-child bonds."

"The pediatric setting is the one place where every baby will show up to be seen by members of a comprehensive care system," said Matthew Melmed, J.D., executive director of ZERO TO THREE. "This program positions and equips all members of the integrated care team to support the unique needs of the parent and the child."

Wheeler's HealthySteps program is part of the organization's Infant and Early Childhood Mental Health (IECMH) Program, which works with families receiving services through Wheeler's Hartford-based Family

Health & Wellness Center whose infants and children, age birth to 12, have experienced trauma, and/or are at risk for, show early signs of, or have been diagnosed with developmental delays, a mental illness, or Neonatal Abstinence Syndrome (NAS). The IECMH program, in partnership with St. Francis Hospital, provides services for infants born with NAS. The IECMH program is funded by a five-year, \$2.5-million grant from the Substance Abuse and Mental Health Services Administration (SAMHSA) and offers a continuum of early childhood services based on the needs of the child and their caregivers through multiple service components, including workforce development, outreach, screening, and direct services.

#### ZERO TO THREE's Nine Elements That Power Positive Parenting

- Imagine your child's point of view, especially during tough moments.
- Notice and celebrate your child's strengths, abilities, and capacity to learn and develop.
- Delight in moments of connection with your child.
- Respond with interest and sensitivity to your child's cues.
- Provide consistent, age-based guidelines, limits, and boundaries.
- Recognize and regulate your own feelings and behaviors before responding to your child.
- Know that parenting can be stressful and missteps are part of raising a child.
- Work toward balancing your needs and your child's needs.
- Seek help, support, or additional information on parenting when you need it.

# Meeting Community Needs

### Immediate Access to Medication-Assisted Treatment (MAT) for Opioid and Alcohol Addiction



Connecticut ranks among the top 10 states for rates of opioid-related overdose deaths. To meet the critical need for education and treatment, Wheeler offers immediate access to medication-assisted treatment (MAT), for opioid misuse, for example, prescription painkillers, fentanyl, and heroin, as well as alcohol use. at

convenient locations in central Connecticut.

"Opioid and alcohol addiction are significant challenges that extend across all geographic and demographic lines," said Susan Walkama, LCSW, president and chief executive officer of Wheeler. "It's critical for individuals and families to know that there are effective, immediate treatment options available and that recovery is possible." Wheeler offers extended-release injectable Naltrexone (Vivitrol<sup>®</sup>) and Buprenorphine (Suboxone<sup>®</sup>, Zubsolv<sup>®</sup> or Bunavail<sup>®</sup>), which provide effective treatment for addiction. These approaches allow patients to stay abstinent longer, experience fewer cravings, and decrease chance of relapse. NARCAN<sup>®</sup> also is available to patients, friends and family. When combined with individual and/or group therapies, MAT is an effective, evidence-based treatment for addiction.

According to the Centers for Disease Control and Prevention, from 1999 to 2017, more than 702,000 people have died from a drug overdose. In 2017, more than 70,000 people died from drug overdoses, and of those deaths, almost 68 percent involved a prescription or illicit opioid.

Initial clinician evaluations are available at Wheeler community health center locations without an appointment.

# Delta Dental of New Jersey Foundation, Inc. Extends Support for Dental Care in Hartford: More than 760 patients received services in first year



Wheeler received its second year of funding for \$50,000 from Delta Dental of New Jersey Foundation, Inc. to address the oral health needs of children and families in Greater Hartford. This grant helps Wheeler's dental team to deliver a full array of on-site family dental services through its community

health center at 43 Woodland Street, Hartford and engage patients in oral health education and active participation in dental care.

In 2018, Wheeler received funding from Delta Dental to help establish a community oral health program in Hartford serving low-income, medically underserved individuals, with an emphasis on children. Launched in January 2018 and providing a full range of dental services such as cleanings, screenings, sealants, X-rays, prevention, and more, Wheeler's dental program served 764 patients, providing 4,173 distinct services in 2,241 visits, in the first full program year, including 267 children (and 1,217 distinct services). More than 85 percent of children served by the dental program, and 76 percent of all patients, also were engaged in the health center's behavioral health and/or pediatric or primary care services, demonstrating Wheeler's efforts to ensure health center patients receive integrated care to meet all their health needs and improve overall wellness. "Wheeler is providing vital services to the Greater Hartford community, expanding access to dental care for children through their new community oral health program," said Gene F. Napoliello, DDS, chairman, Delta Dental of New Jersey Foundation. "There is a link between good oral health and good overall health, and Wheeler's focus on integrated care will allow countless children and families the opportunity to lead more healthful lives. We were proud to support the inaugural year of this program, and we look forward to another successful year of healthier smiles."

Foundation funds also support the purchase of oral health care education packages, and dental

supplies, including age-appropriate toothbrushes, toothpaste, and coloring books promoting preventative dental care for children. Wheeler's dental assistant and community engagement team distribute dental care materials at health fairs, community block parties, and neighborhood events and actively work to integrate dental programs into primary care services.

Collaboration with Wheeler's nutritionist and toddler nutrition classes also are part of this effort.


