#### **CARING FOR MEDICALLY UNDERSERVED POPULATIONS**

- Opened a new community health center at 100 Jefferson Square, Waterbury, to meet the whole-health needs of individuals in the Greater Waterbury area.
- Expanded programs and services at the Wheeler Family Health & Wellness Center at 43 Woodland Street, Hartford.
  - Launched nutrition education and counseling services, including a Toddler Nutrition Program, made possible with support from the Corsini and Brantner Families.
  - Provided fresh vegetables through the Fresh Access Program, supported by Holcomb Farm and the Hartford Foundation for Public Giving.
  - Introduced no-drill dentistry, a non-surgical alternative.
  - Opened an on-site Genoa Healthcare full-service pharmacy to provide additional convenience to patients.
  - Met the oral health needs of children and families with a second year of funding from the Delta Dental of New Jersey Foundation, Inc.

- Broadened women's health services to include reproductive health and childbirth services, annual exams, counseling, and linkages to other services.
- Expanded early childhood services and became the first in Connecticut to implement the HealthySteps program for children birth through five, part of a SAMHSA-supported \$2.5-million grant to address Neonatal Abstinence Syndrome and mental illness.
- Planned and implemented structural improvements through a State Nonprofit Grant of \$465,000.
- Expanded services at Wheeler's Family Health & Wellness Center, Bristol, to include primary care, behavioral health, and addiction treatment services in two locations:
   10 and 225 North Main Street.
- Provided nutrition education, counseling services, and supports to patients at the Family Health & Wellness Center in New Britain through a grant from the A.W. Stanley Discretionary Fund at the Community Foundation of Greater New Britain.

#### LEADING THE WAY IN ADDICTION SERVICES, HEALTH PROMOTION

- Launched the Youth and Family TREE program to expand and enhance care for transitional-aged youth with substance use disorders in Hartford, supported by a five-year, \$2.7-million federal grant from SAMHSA.
- Led statewide National Prevention Week initiatives to include a forum on "The Physiology of Addiction."
- Significantly expanded in-home services for youth with substance use issues, oppositional behaviors, and family conflict in Greater Waterbury, Danbury, Torrington, and Greater New Haven, with support from DCF.
- Served parents and caregivers with substance use concerns in Greater Hartford, Meriden, and Manchester through the SAFE Recovery Program, funded by DCF.

- Provided opioid recovery support services in collaboration with the City of Bristol through a \$150,000 grant from the Department of Mental Health and Addiction Services (DMHAS).
- Hosted community quilting events, as part of the Department of Mental Health and Addiction Services Remembrance Quilt Project, to honor the memory of those lost to substance use disorders.
- Launched a multi-faceted online and outdoor campaign to raise awareness for problem gambling and Wheeler's Bettor Choice Gambling Treatment Program.

#### RECOGNIZED FOR EXCELLENCE

- Uniquely earned four accreditations and certifications from The Joint Commission, the only community health center in Connecticut with both primary care medical and behavioral health home certifications, and only one of five nationwide with a unique combination of accreditations and certifications.
- Received \$122,000 in federal awards for quality care, including special recognition as the only health center in Connecticut ranked in the top two percent of all centers nationally that improved quality of care between 2017 and 2018 in one or more measures that promote behavioral health, diabetes health, and heart health.
- Featured in a 2019 *US News & World Report* story, "Mobile Help for Mental Health."
- Honored as a Platinum-level, award-winning "Healthy Workplace" by the Business Council of Fairfield County.

#### **EXPANDING SERVICES TO MEET NEED**

- Trained hundreds of public safety professionals in Mental Health First Aid® through a \$375,000 federal SAMSHA grant.
- Expanded Collaborative Learning Programs to the Southington school district, providing in-district support to students struggling in traditional academic settings.
- Assisted and treated survivors of Hurricane Maria with support from a one-year federal grant from SAMHSA.
- Shared behavioral health information and resources with hundreds of Southington residents through the Southington Health Outreach Project, funded by The Main Street Community Foundation.
- Awarded funding from DCF to launch a program that helps young adults in the foster care system transition to adulthood.
- Launched the Collaboration for Community Health program
  with the Hispanic Health Council to increase access to health
  care for underserved behavioral health patients at risk for
  chronic health conditions. A \$225,000 grant from the
  Hartford Foundation for Public Giving supports this effort.

#### 34TH ANNUAL WHEELER GOLF CLASSIC

Wheeler's 34<sup>th</sup> Annual Golf Classic, presented by Mutual of America, raised nearly \$60,000 and crossed the \$1.2-million fundraising mark since its inception in 1986.

This year, proceeds support Wheeler's community health centers in Hartford, New Britain, Bristol, and Waterbury, as well as the organization's Basic Needs Fund, which addresses a range of environmental and social factors that interfere with a patient's health and well-being and improves outcomes. The Basic Needs Fund tackles issues such as food insecurity and access to healthy options, transportation, childcare, healthy physical environments, and more.

#### HANDS AND HEARTS

Twelve organizations and individuals received awards at Wheeler's ninth annual Hands & Hearts reception in May. The event honored individuals, families, corporations, and foundations for their outstanding support of Wheeler's mission. The 2019 honorees include State Representative Catherine Abercrombie (D-83); Claire Holden and Aline Towne; Mutual of America; People's United Bank; and Jane Tedder, Ed.D. Special awards for 10 years of board service were presented to Jake Biscoglio, Richard E. Cartland, William D. Gombatz, Christine Skelly, Gary Thomas, and William J. Torres.


