MESSAGE FROM OUR PRESIDENT AND BOARD CHAIR

REDUCING HEALTH DISPARITIES, ELIMINATING RACIAL INJUSTICE, AND DELIVERING ACCESSIBLE CARE.

A year ago, none of us could have foreseen the striking challenges ahead for our communities and the individuals and families we serve. At Wheeler, the COVID-19 pandemic and national unrest brought our organizational priorities directly to the forefront, most notably the unequivocal need to eliminate inequality and ensure that our most vulnerable populations across Connecticut have access to essential behavioral health and primary care. We remain steadfast in our commitment to delivering high-quality services, and we are relentlessly determined to remove barriers that interfere with access.

At the start of the crisis, our health teams moved almost entirely to telemedicine, safely and effectively. Our behavioral health, community-based services, and education teams delivered inspired, compassionate academic instruction and innovative therapeutic activities for children and families.

Prior to—and amid—the challenges of 2020, we experienced notable growth across Wheeler, particularly in integrated care delivery. We moved to an expanded health center facility in Waterbury, addressing pressing issues in this community through addiction treatment, primary care, and behavioral health services across the lifespan. We implemented a model of care that blends primary care and behavioral health services at our community health center in Hartford, where our teams work side-by-side to meet the whole-health needs of patients. We launched a program to serve young adults transitioning from the foster care system. As this publication goes to print, we are transforming our clinical site at 91 Northwest Drive in Plainville to a federally qualified health center—our fifth community health center—joining others in Bristol, Hartford, New Britain, and Waterbury.

The expansion of our programs and services is driven by a rigorous approach, which has earned us recognition as a leading provider statewide and nationally. Most recently, we were acknowledged by the federal Health Resources and Services Administration (HRSA) as one of only two community health centers in Connecticut that met or exceeded goals for reducing health disparities across different racial and ethnic groups.

As we consider all that we have accomplished, we know that our work would not be possible without assistance from our donors and friends like you.

As we move ahead, the future looks hopeful, and our purpose is clear. We will continue the fight to eliminate health, racial, economic, and social disparities so that individuals and families can access care and discover opportunities to live healthier, more productive lives.

Thank you for embracing our vision and supporting our mission. Health, recovery, and growth are possible because of you.

91 Northwest Drive Site Becomes Fifth Community Health Center

Location was the original site of the mental health outpatient clinic since 1972.

Wheeler is transforming the services at its original behavioral health clinic location at 91 Northwest Drive, Plainville, to offer fully integrated primary and behavioral health care in one location.

The new Plainville Family Health & Wellness Center joins Wheeler's four other community health centers in Bristol, Hartford, New Britain, and Waterbury—and more than 1,300 other federally qualified health centers across the country—as a frontline network of wholeperson health care that keeps nearly 30 million Americans well.

Patient-centered, fully integrated health care, coordinated referrals to specialty care, and services to meet patient needs and advance individual and population health outcomes crucial to the Plainville community. In addition, an expanded Family Health & Wellness Center will open in New Britain to include pediatric and children's behavioral health services.

YEAR IN REVIEW

NAVIGATING CRISIS, SERVING COMMUNITIES

- Shifted majority of behavioral health and other services to telehealth delivery in response to the COVID-19 crisis.
- Delivered a robust array of virtual instruction and learning to Northwest Village School students in the spring and summer of 2020.
- Launched company-wide Diversity and Inclusion initiative as part of Wheeler's fight against racial injustice.
- Purchased personal protective equipment (PPE) and provided a safe environment of care at our four community health centers, thanks to a \$50,000 grant from Direct Relief, in partnership with the National Association of Community Health Centers.

EXPANDING CARE, MEETING NEED

- Started transformation of 91 Northwest Drive, Plainville, as Wheeler's fifth federally qualified health center.
- Opened and expanded community health care facility at 855 Lakewood Road, Waterbury.
 - Launched array of primary care and behavioral health services, including expansion of pediatric and child behavioral health and medication-assisted treatment (MAT) for addiction.
 - Opened on-site Genoa Healthcare full-service pharmacy and Quest Diagnostics laboratory services to provide additional convenience to patients.
 - Expanded access to the life-saving medication naloxone, NARCAN[®], for individuals who otherwise would not have access, thanks to a grant from American Savings Foundation.
- Expanded integrated care and services at Hartford community health center location.
 - Launched model of care to further integrate primary care and behavioral health services.
 - Introduced Saturday hours to better serve Greater Hartford residents.
 - Increased accessibility and safety at this facility, thanks to a grant from the State of Connecticut Nonprofit Grant Program.
- Launched program to help young adults transition from the foster care system to life as an independent adult, with funding from the Connecticut Department of Children and Families.
- Expanded school-based behavioral health services in all 12 Bristol Public Schools.

FORGING PARTNERSHIPS, CHANGING LIVES

- Expanded access to fresh produce for patients at Wheeler's four community health centers, thanks to a \$12,000 commitment from Wheeler through private donations and a \$12,000 matching gift from The Friends of Holcomb Farm through their Fresh Access Program.
- Worked closely with Health Ambassadors from Mott Corporation on events and projects to meet community need.

EXCEEDING BENCHMARKS, REACHING GOALS

- Received federal grant awards from the U.S. Department of Health and Human Services Health Resources and Services Administration (HRSA) for reducing disparities in health care and improving quality and access. Recognized by HRSA as only one of two community health centers in Connecticut that met or exceeded goals for reducing health disparities across different racial and ethnic groups between 2018 and 2019.
- Honored as a Platinum-level, award-winning "Healthy Workplace" for the second consecutive year by the Business Council of Fairfield County.
- Recognized as a 2020 Top Workplace, Wheeler's seventh recognition. Wheeler's President and Chief Executive Officer, Sabrina Trocchi, also received a special designation for Leadership in the Large Employer category.

Ms. Walkama retired on November 1, 2019 after nearly 40 years at Wheeler, including more than a dozen as president and CEO, a time during which she dramatically transformed Wheeler, driving the organization to become a federally qualified health center and refocusing care on the integration of all health care services.

BASIC NEEDS FUND

Many individuals and families across Connecticut have struggled to meet their own basic needs, particularly over the last year. Wheeler was able to help through its Basic Needs Fund, which addresses environmental conditions that might lead to poor health outcomes.

This fund is supported through private giving, from direct gifts, to proceeds from the Wheeler Golf Classic, and the generosity of partners like Mott Corporation, whose team helped stuff 1,000 bags of personal care items for patients in need, just prior to the pandemic. Additionally, in preparation for the school season, this fund supported the assembly and distribution of student backpacks filled with supplies, including face masks and hand sanitizers, for children who visited Wheeler's Family Health & Wellness Centers in Bristol, Hartford, and Waterbury.

HONORING LIVES AND LEGACIES THROUGH FUNDING, NUTRITION PROGRAMMING

Wheeler honored the life of late, former long-time board member Raymond Corsini through programming that reflects his passion for cooking, healthy food, and approaches to sustainability. A generous donation from the Corsini and Brantner Families and a matching gift



campaign in 2019 in honor of former Wheeler President and CEO Susan Walkama, LCSW, which was spurred on by an anonymous \$25,000 matching gift challenge, raised more than \$60,000 for nutrition programming, which currently is offered through lively demonstrations and discussions on Facebook Live, telemedicine, and in-person appointments.

ADDICTION SERVICES SAVING LIVES

Residents in the Waterbury region have easier access to a lifesaving medication used to reverse overdoses, thanks to the American Savings Foundation, which awarded Wheeler a \$2,000 grant to purchase and provide naloxone (NARCAN®). This grant is matched with support from The Brian and Marilyn Lindsay Foundation. The medication is available through Wheeler's Waterbury community health center.
