School-Based Health Centers in Bristol and New Britain

Wheeler’s school-based health centers help students with anxiety, depression, academic and peer challenges, trauma-related issues, including post-traumatic stress disorder (PTSD), substance abuse, and much more.

They also provide connections to other services, including primary and dental care at **Wheeler’s Family Health & Wellness Center at 10 and 225 North Main Street Bristol**, and **Wheeler’s Family Health & Wellness Center at 40 Hart Street, New Britain**.

SCHOOL-BASED SERVICES INCLUDE:

- Integrated behavioral health assessment
- Individual, family or targeted group therapy
- Coordination of care with the school
- Facilitation of primary and dental care

CONTINUUM OF SERVICES

As part of Wheeler’s comprehensive continuum, our school-based clinicians can assist with care coordination with other evidence-based services available at Wheeler. Medication management and primary and dental care are available through Wheeler’s Family Health & Wellness Center.

ACCESS TO CARE

Parents or legal guardians may contact their school social worker to schedule an initial appointment. A Wheeler school-based clinician will conduct an assessment to determine the best approach for care. Parents or legal guardians of existing Wheeler clients who wish to receive additional resources at school may speak with their clinician to coordinate their care.

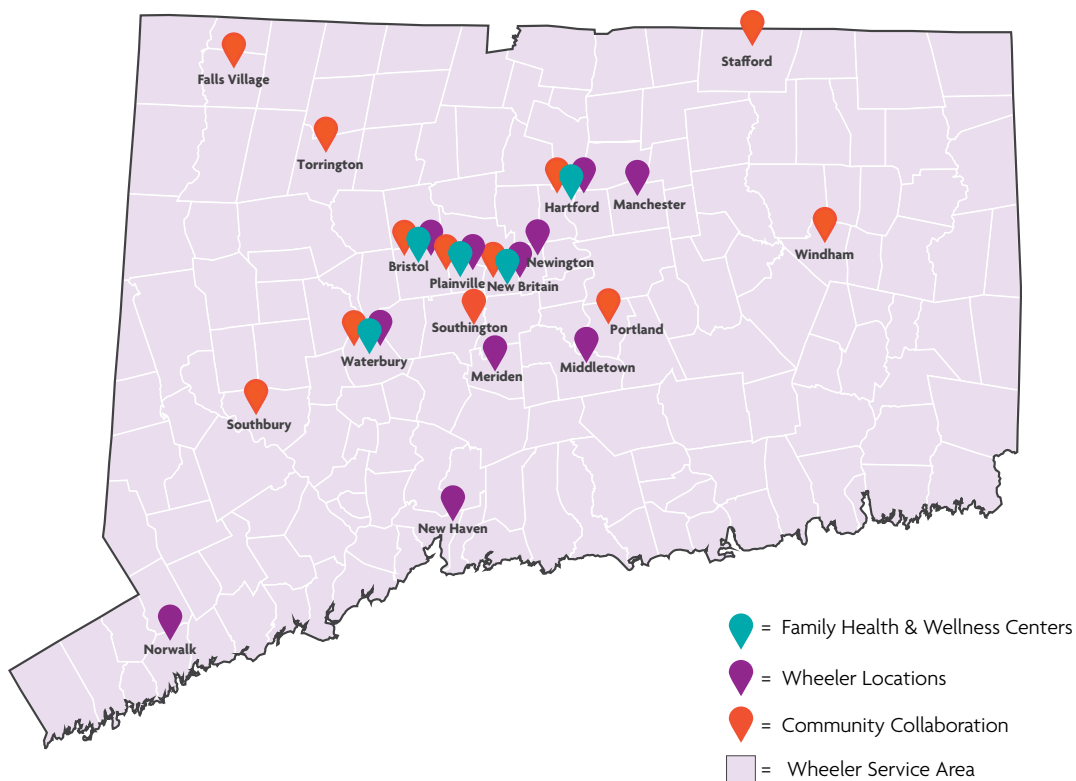
